WHEREAS, the board nominally decided in December 2016 to reimburse up to \$5,000 in related legal fees or expenses to Member B if he was to take his civil tort claim(s) against the County related to his suspension to Court; and

WHEREAS, considerable uncertainty exists regarding, among other things, what kinds of legal expenses the board had intended to be reimbursed to Member B, and under what circumstances and under what conditions such expenses were intended to be reimbursed under the December decision; and

WHEREAS, providing support for Member B in asserting his civil tort claim against the County to the extent of reimbursing his related out of pocket expenses is consistent with Local 88's several other ongoing efforts to advance the interests and representation of on call and other temporary employees of the County; and

HAVING DULY considered the January 3, 2017 letter of attorney BC;

The Board has now reviewed and reconsidered its December decision and decided to clarify and limit it decision as follow.

The Board will reimburse Member B for up to five hundred dollars (\$500.00)of actual, out-of-pocket expenses such as filing fees or copying costs (but not including attorney fees) that John Blake may incur in asserting his civil tort claim(s) against the County related to his suspension, upon Member B's presentation to the Treasurer of satisfactory receipts evidencing the incurrence of such expenses.
